


YOUTH LEADERSHIP



The fight for food Justice is a grassroots struggle emerging from communities in response to food insecurity and economic pressures that prevent access to healthy, nutritious, and culturally appropriate food.

How Many Children Struggle with Food insecurity?

There are 9 Million Children in the United States who live with food insecurity. How many children starve each day? 3.1 million children are starving in the United States. A child dies from hunger every 10 seconds! One of the largest contributors to food insecurity is climate change. In addition, communities living in poverty lack equal access to resources leaving many unable to afford the food they need.

The lack of Food Justice has such a big impact in the United States which makes it hard for families to have access to food and the healthy nutritious food they need. Some way we can make a change in the high rates of food insecurity is that more food programs produce a fair amount of food so that all families can access amounts the right size for their families. We need more support and funds to help us get the food and resources we need and put a stop to poverty. We need to help families find better jobs and give them better pay to buy food. FOOD JUSTICE IS SOCIAL JUSTICE



FOOD INJUSTICE IN THE BRONX
COMMUNITY INTERVIEW BY ESTRELLA MENDEZ AND JOANNA RAMOS

Q.HOW DO YOU FEEL ABOUT FOOD INJUSTICE? AND WHAT DOES IT MEAN TO YOU?

A:“ITS DIFFICULT CAUSE GROWING UP POOR YOU SEE THAT EVERYONE JUST ASSUMES THE GOVERNMENT IS GONNA GIVE YOU FOOD AND THEY WILL TO SOME DEGREE BUT **MOST OF THE FOOD IS EITHER UNAPPETIZING OR IT'S UNBALANCED.** I KNOW WHY YOU GUYS EAT JUNK FOOD BECAUSE TO BUY FRUIT OR VEGETABLES IT'S LIKE 20 TIMES THE COST OF WHERE I LIVE. **I SEE FOOD INJUSTICE AS THE ACCESS YOU GUYS HAVE TO FOOD AND I DON'T THINK YOU GUYS HAVE THAT.** (REFERRING TO US TEENAGERS.)”

B:“I'VE NOTICED RECENTLY THAT MY GROCERY STORE HAS A LOT OF FOOD THAT NEEDS TO BE FRESH AND PERISHABLE. THERE'S JUST NEVER ANYTHING, MAYBE LIKE 3 BAGS OF LETTUCE...”

Q.IF YOU HAD THE POWER OR ABILITY TO MAKE A CHANGE IN THIS ISSUE WHAT STEPS WOULD YOU TAKE?

A:“ITS DIFFICULT...PROBABLY TRY AND PARTNER UP LOCAL FARMERS WITH NEIGHBORSHOODS THAT ARE FACING FOOD INSECURITY... **ITS A DIFFICULT QUESTION BECAUSE THERES SO MANY ELEMENTS THAT FALL INTO FOOD INJUSTICE THAT MAKE STEPS HARD TO COME UP WITH TO SOLVE THIS ISSUE”.**

B: ADDRESSING ALL OF THOSE ARE STARTING AT ONE POINT AND THEN BRANCHING OUT STARTING WITH MAKING SURE THERE IS ENOUGH FOOD FOR EVERYBODY LIKE CHEAP AVAILABLE NOT RAN UP BY THE MARKET AND THINGS LIKE THAT”

HOW DO YOU THINK RACISM PLAYS A BIG ROLE IN FOOD INJUSTICE?

“YES ABSOLUTELY BECAUSE HERE IN THE CITY WE'RE **SEGREGATED. WE'RE DIVIDED INTO RACE GROUPS AND WHEN YOU GO TO CERTAIN RACE GROUPS THE FOOD THEY ARE BEING SOLD ISN'T UP TO DATE SOME ARE UNHEALTHY, UNAPPETIZING AND SOME ARE JUST SPOILED FOOD.”**





I grew up eating cheap unhealthy food.







Fast Foods In The Bronx



A STORY UNTOLD

IT WAS 8 PM ON A BEAUTIFUL SUMMER EVENING. MY FRIEND JOHN AND I WERE PLAYING THE BEST GAME OF FLAG FOOTBALL WITH ABOUT 8 OTHERS. MUD FOLLOWED OUR FOOTSTEPS AS WE RAN IN THAT SWAMPY FIELD. IT WAS LIKE OUR MOODS WERE RUNNING OFF OUR GENUINE LAUGHS WHICH WERE SO LOUD. MARIA THE OLD LADY STUCK HER HEAD OUT THE WINDOW FROM DOWN THE BLOCK TELLING US TO SHUSH ABOUT 3 TIMES. JOHN THREW THE BALL TO ME, I CAUGHT IT BUT ACCIDENTALLY LANDED THE WRONG WAY AND FELL OVER.

FOR ABOUT 4 SECONDS SILENCE FILLED THE AIR AS ALL LAUGHS BLEW AWAY AND WORRIED FACES STOOD UPON ME. FOR ABOUT 4 SECONDS LAID ON THE FLOOR BUT ON THE 5TH SECOND THE FOOTBALL ROSE FROM MY BODY AND EVERYONE CHEERED SO LOUD. JOHN INFORMED ME BEFORE PLAYING ANOTHER GAME THAT HIS CHEST WAS FEELING TIGHT AND INSISTED HE SHOULD GO HOME. "COME ON JOHNNY FOR ALL THAT TRASH TALKING YOU DO, YOU GOTTA HAVE A FEW MORE PASSES IN YOU." I TOLD JOHN NOT KNOWING THAT WOULD BE THE WORST CHOICE OF MY LIFE. I HAD A FEW SIPS OF WATER IN MY WATER BOTTLE WHICH I GAVE JOHN BUT IT WAS ENOUGH TO FIX THE DEHYDRATION MOST LIKELY. HE TOLD ME HE HAD A FEW MORE GAMES IN HIM AS HE WAS GASPING FOR AIR. THE SUN STARTED TO LEAVE US BEHIND ON THE FIELD AS THE LAMPOST LIGHTS REPLACED IT TO BRIGHTEN THE NIGHT SKY.

WE WENT ON TO PLAY ANOTHER GAME AND ANTHONY SAID "I'M ABOUT TO MAKE YOU QUIT THE ONLY SPORT YOU ARE DECENT AT." FOR SOME STRANGE REASON JOHN DIDN'T REPLY WHICH WAS ABNORMAL BECAUSE JOHNNY WAS THE BIGGEST TRASH TALKER ANYONE KNEW. WE THEN PROCEEDED TO PLAY AND JOHN'S ARM WAS A LITTLE OFF FOR THE FIRST THROW. THE OTHER TEAM CAUGHT AN INTERCEPTION AND SCORED. WE SCORED A LUCKY TOUCHDOWN AND THE SCORE BECAME TIED. THIS WAS OUR 3RD DOWN IF I DIDN'T CATCH THE BALL AND WE WOULD'VE MOST LIKELY LOST.

JOHN THREW THE BALL SO FAR , I SWORE HE PROBABLY WOULD'VE BEEN IN THE NFL WITH THAT PIN PERFECT THROW. I CAUGHT THE

BALL AND THE CITY HEARD MY TEAM'S CHANTS. BUT BESIDES ME CATCHING THAT BALL I STILL MISSED SOMETHING. I MISSED THE FACT THAT MY BEST FRIEND'S BODY COLLAPSED ON THE FLOOR STRUGGLING TO BREATHE. I TOLD MY FRIEND MIKE TO RUSH AND CALL THE POLICE SO HE RAN FAST TO THE PHONE. THE COPS GOT THERE IN 10 MINUTES. WHEN THEY TOOK HIS BLUE BODY INTO THE ABUNDANCE I RAN UNTIL MY LEGS WERE OUTSIDE OF THE HOSPITAL.

WHEN WE GOT THE NEWS JOHN DID NOT MAKE IT AND PASSED AWAY FROM AN ASTHMA ATTACK I STOOD STANDING WITHOUT A SINGLE MOTION. JOHN MIGHT HAVE DIED THAT DAY BUT MY SOUL WENT WITH HIM TO HEAVEN. FOR MONTHS I WASN'T ABLE TO SLEEP WITH THE GUILT THAT RAN AROUND IN MY HEAD. "IF ONLY I TOLD HIM TO GO HOME HE WOULD BE HERE WITH ME RIGHT NOW." I BLAMED MYSELF FOR SO LONG BUT I FAILED TO REALIZE SOMETHING. AFTER DOING RESEARCH ON ASTHMA I FOUND OUT 1-4 PEOPLE IN THE BRONX, IN MY COMMUNITY SUFFER FROM THE DISEASE. THERE WAS SOMETHING GOING ON AND I JUST COULDN'T SEE IT.

LITTLE DID I KNOW THE PROBLEM WAS RIGHT IN FRONT OF OUR FACES ALL OVER IN OUR COMMUNITY. TRASH EVERYWHERE NOT BEING MAINTAINED, TRASH TREATED RIVERS, DESTRUCTIVE HIGHWAYS FARTING TERRIBLE GASES INTO OUR LUNGS. WE HAD TO DO SOMETHING FOR OUR COMMUNITY, FOR JOHN! WANT ENVIRONMENTAL JUSTICE! WE WANT EQUALITY! WE WANT TO BE TAKEN SERIOUSLY! WE WANT OUR RIGHTS! BUT MOST IMPORTANTLY WE NEED TO BE HEARD! JOHN IS NOT THE ONLY ONE WHO WOULD NEVER GET TO SEE THE DAY OF LIGHT AGAIN BECAUSE THE GOVERNMENT WON'T TRY AND CLEAN UP A MESS THEY MADE!



Air Quality in Hunts Point

Reana Porras interviewing Bronx residents and students, Athena Dilaura and Brandon Gonzalez

Q: How would you describe the air quality in Hunts Point?

Athena: The air quality in Hunts point is terrible. With all the trucks and gas that contaminates the air, it attacks the asthmatic people. I personally suffer from this everytime I come over here.

Brandon: The air quality in hunt point is harmful.

Q: Do you or someone you know has asthma? If so, do you think the air quality plays a part in it?

Athena: I have asthma and coming to the hunts point community I have to constantly make sure I have my asthma pump on me because at some moments I start to feel a tight pain in my chest, especially when i'm doing something outside. I hate this area.

Brandon: Yes, my great grandma got asthma. The air quality definitely plays a part in it.

Q: How do you think we can start improving the air quality?

Athena: to improve the air quality in Hunts Point, trucks should be limited. To improve the quality of the air they should put some type of filter on the trucks. We improved in technology and we should be able to figure out how to make the gas that comes out of trucks cleaner.

Brandon: First we gotta be heard, people have to start noticing us. The government got to start cleaning up its mess.

particulate matter 2.5 (PM2.5):

Particles are defined by their diameter for air quality regulatory purposes. Those with a diameter of 10 microns or less (PM10) are inhalable into the lungs and can induce adverse health effects. Fine particulate matter is defined as particles that are 2.5 microns or less in diameter

Environmental Justice communities, including **Hunts Point**, are disproportionately exposed to PM2.5 pollution, and as a result, suffer from higher rates of respiratory illness, heart disease, stroke, lung cancer, negative birth outcomes, and other life-threatening conditions associated with breathing dirty air on a daily basis







AN ENVIRONMENTAL JUSTICE CRISIS:

LAST-MILE TRUCKING FACILITIES

Over 2 million packages are delivered in NYC each day, leading to increases in truck traffic and emissions.


THE THREAT OF MORE WAREHOUSES

MORE TRUCK TRAFFIC, NOISE, & AIR POLLUTION

These types of facilities are fundamentally different from traditional warehouses that store excess inventory—due to their larger size and intensive truck usage—and will bring thousands of additional diesel trucks & delivery vans to New York City's already congested streets. Without new controls, these vehicles will emit tons of toxic air pollutants into neighborhoods already suffering from poor air quality and associated health impacts.

UNREGULATED ZONING

These giant facilities do not undergo any public review process or environmental review because they are not defined under zoning law, so NYC Department of City Planning treats them as **“warehouses”** which can be constructed **“as-of-right”** in manufacturing districts and C8 commercial districts. These trucking facilities are being concentrated in communities of color and low-income communities, where residents, schoolchildren, and workers have long been exposed to disproportionately high levels of harmful vehicle exhaust.

CREATING A ZONING RESOLUTION TEXT AMENDMENT

Frontline environmental justice communities across NYC faced with the impacts of giant last mile trucking facilities have come together to work collaboratively with partners & allies to develop a citywide initiative to pass a Zoning Resolution Text Amendment for a Special Permit.

THE ZONING RESOLUTION MUST:

- Define last-mile facilities based on size & number of vehicle trips per day
- Require last-mile developers to seek a special permit from the City Planning Commission
- Direct the city to consider impacts on vehicular congestion and air pollution in surrounding frontline communities
- Require compliance with zoning standards to protect our waterfront
- Prevent the clustering of last-mile facilities in frontline communities
- Require facilities to use renewable energy and not fossil fuels for onsite & operational activities
- Align with New York's Climate Leadership & Community Protection Act mandates

Between 2015-2018, truck traffic volumes have grown by 21% and is expected to continue to grow.




